**AN EXECUTIVE ORDER AMENDING THE EXECUTIVE ORDER
CREATING THE COMMITTEE ON ANTI-RED TAPE (CART) IN THE
LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY**

WHEREAS, Republic Act No. 11032, otherwise known as the "Ease of Doing Business and Efficient Government Service Delivery Act of 2018", mandates all government agencies to adopt simplified requirements and procedures that will reduce red tape and expedite business and non-business related transactions;

WHEREAS, the Anti-Red Tape Authority (ARTA) issued Memorandum Circular No. 2020-07, Series of 2020, directing all government offices to designate a Committee on Anti-Red Tape (CART) and providing the guidelines thereof;

WHEREAS, said circular instructs agencies with existing unit to comply with the Anti-Red Tape Act of 2007 (R.A. No. 9485), as amended by R.A. No. 11032, and should be reorganized as the CART;

WHEREAS, Executive Order No. 41, Series of 2022, provided for the creation of the Committee on Anti-Red Tape (CART) in the Local Government Unit of General Santos City;

WHEREAS, there is a need to amend the said Executive Order to reorganize the CART;

NOW, THEREFORE, I, LORELIE G. PACQUIAO, City Mayor of General Santos, by virtue of the power vested in me by law and the sovereign will of the people, do hereby order the following:

SECTION 1. Section 1 of Executive Order No. 41, Series of 2022 is hereby amended and shall be read as follows:

"SECTION 1. CREATION. There shall be created a Committee on Anti-Red Tape (CART), which shall be composed of the following:

- Chairperson:** Department Head, City Treasurer's Office
- Vice
Chairperson:** Department Head, Office of the Building Official
- Members:** City Administrator
City Legal Officer
Department Head, Human Resource Management and Development Office
Department Head, City Assessor's Office
Department Head, City Planning and Development Office
Division Chief, Business Permits and Licenses Division
Secretary to the Sangguniang Panlungsod"



SECTION 2. Section 3 of Executive Order No. 41, Series of 2022 is hereby amended and shall be read as follows:

"SECTION 3. SECRETARIAT. The City Treasurer's Office shall serve as the CART's Secretariat tasked to handle all administrative and secretarial activities."

SECTION 3. REPEALING CLAUSE. All orders, memoranda, rules and regulations, or any part(s) thereof, inconsistent with the provisions of this Order are hereby revoked or modified accordingly.

SECTION 4. SEPARABILITY CLAUSE. If any provision or part hereof is held invalid or unconstitutional, the remainder of this Order not otherwise affected shall remain in full force and effect.

SECTION 5. EFFECTIVITY. This Order shall take effect immediately and shall remain in full force and effect unless otherwise revoked or amended.
