



**EXECUTIVE ORDER NO. 45**

**AN EXECUTIVE ORDER AMENDING SECTION 1 OF EXECUTIVE ORDER NO. 4, SERIES OF 2022, CREATING THE LOCAL ZONING REVIEW COMMITTEE (LZRC)**

**WHEREAS**, the City Mayor issued Executive Order No. 4, Series of 2022 or "An Executive Order Creating The Local Zoning Review Committee (LZRC)";

**WHEREAS**, there is a need to reorganize the LZRC and specify the Private Sector Representatives and Non-Government Organizations from the pool NGOs and Civil Society Organizations accredited by the Sangguniang Panlungsod;

**WHEREAS**, time is of the essence and this necessitates the rationalization of the membership of the LZRC to ensure quorum to conduct business and discharge its functions.

**NOW, THEREFORE, I, LORELIE G. PACQUIAO**, City Mayor of General Santos, by virtue of the power vested in me by law and the sovereign will of the people, do hereby amend the membership of the Local Zoning Review Committee (LZRC):

**SECTION 1.** Section 1 of Executive Order No. 4, Series of 2022 is hereby amended to read as follows:

Community Association, Incorporated.”

**SECTION 2. REPEALING CLAUSE.** All orders, memoranda, rules and regulations or any part/s thereof, inconsistent with the provisions of this order are hereby revoked or modified accordingly.

**SECTION 3. SEPARABILITY CLAUSE.** If any provision thereof is held invalid or unconstitutional, the remainder of this Order not otherwise affected shall remain in full force and effect.

**SECTION 4. EFFECTIVITY.** This order shall take effect immediately.
