



**EXECUTIVE ORDER NO. 49**  
**Series of 2022**

**AN EXECUTIVE ORDER REORGANIZING AND RECONSTITUTING THE PROJECT MONITORING COMMITTEE (PMC) OF GENERAL SANTOS CITY**

**WHEREAS**, Executive Order No. 376, series of 1989, as amended by Executive Order No. 93, Series of 1993, a Project Monitoring Committee must be constituted to monitor and evaluate all programs and projects in the Local Development Investment Program (foreign-funded and GAA-funded), including development projects funded from the Internal Revenue Allotment (IRA) share of LGUs or supported by funds released directly to the City Government and projects funded from locally-generated resources which are implemented within the territorial jurisdiction of General Santos City;

**WHEREAS**, the PMC is an important independent body that will ensure that project implementation is in accordance with identified development priorities, programs, plans and specifications and to recommend policies for an improved program and project implementation at all levels of government;

**WHEREAS**, it is stipulated in Section 1.C of EO No. 26, series of 2022 "An Executive Order Reconstituting and Reorganizing the City Development Council (CDC) and its various Committees", that the Project Monitoring Committee is one of the working committees;

**NOW THEREFORE, I LORELIE G. PACQUIAO**, City Mayor of General Santos, by virtue of the power vested in me by law and the sovereign will of the people, do hereby order the following:

**SECTION 1. COMPOSITION.** The City Project Monitoring Committee (CPMC) shall be composed of the following:

Chairperson: Representative, Notre Dame of Dadiangas University (NDDU)

Vice-Chairperson: Representative, Southmin Ihome Incorporated (SII)

Members:

- Representative, Department of the Interior and Local Government (DILG)
- Representative, Nursery Farmers Irrigators Association (NFIA)
- Representative, General Santos City Small and Medium Enterprise Development Council (SMEDC)
- Representative, Workers Multi-Purpose Cooperative of the Philippines (WMCP)
- Representative, OND HESED Foundation

Secretariat: City Planning and Development Office (CPDO)



**SECTION 2. DUTIES AND RESPONSIBILITIES.** The CPMC and CPMC Secretariat shall perform the following duties and responsibilities:

- Provide the list and schedule of all projects to be monitored to NGOs/ POs and CSOs involved in project monitoring;
- Collect and process reports of implementers and NGOs/ POs and CSOs monitors on the status of project implementation for the information of the CDC and next higher-level PMC;
- Determine problems related to the implementation of programs and projects and verify information to be submitted for analysis and action of the CDC;
- Provide feedback on the remedial actions of the CDC and follow up implementation;
- Prepare and disseminate periodic project monitoring report on the status of project implementation to the Regional PMC (RPMC); and
- Elevate to higher level bodies (e.g., National PMC (NPMC), RPMC) issues and problems which are not resolved at the CPMC level.

**CPMC Secretariat:**

- Prepare the monitoring and evaluation (M&E) work program to be undertaken by the PMC during any given fiscal year which will include the list of the projects and schedule of implementation based on submission of implementing agencies;
- Provide the Local Chief Executive with information on the projects to be monitored by the PMC; and
- Facilitate inter-agency, inter-governmental, and field headquarters coordination, if necessary.

**SECTION 3. REPEALING CLAUSE.** All orders, memoranda, rules and regulations or any part/s thereof, inconsistent with the provisions of this order are hereby revoked or modified accordingly.

**SECTION 4. SEPARABILITY CLAUSE.** If any provision thereof is held invalid or unconstitutional, the remainder of this Order not otherwise affected shall remain in full force and effect.

**SECTION 5. EFFECTIVITY.** This order shall take effect immediately.
