

EXECUTIVE ORDER NO. 40 Series of 2022

AN EXECUTIVE ORDER AMENDING EXECUTIVE ORDER NO. 31, SERIES OF 2022, RECONSTITUTING THE PEOPLE'S LAW ENFORCEMENT BOARD OF GENERAL SANTOS CITY

WHEREAS, Republic Act No. 6975 or the *Department of Interior and Local Government* (*DILG*) *Act* provides for the creation, functions, composition, compensation of the People's Law Enforcement Board (PLEB) and the prescribed procedures therein;

WHEREAS, Republic Act No. 8551 or the *Philippine National Police Reform and Reorganization Act of 1998* strengthened the People's Law Enforcement Board by adding the creation of one (1) PLEB for every five hundred (500) city or municipal police personnel and one for each of the legislative districts of the city and introduced other amendments to enhance the PLEB;

WHEREAS, Rule 11 of the National Police Commission Memorandum Circular 2016-002 or the *Revised Rules of Procedure Before the Administrative Disciplinary Authorities and the Internal Affairs Service of the Philippine National Police* dated March 7, 2016 specified certain guidelines for the creation, functions, composition, resolution and executive order constituting the PLEB, and other aspects;

WHEREAS, the DILG issued Memorandum Circular No. 2017-154 dated November 16, 2017, which prescribed the Operational Guidelines on the Implementation of the PLEB Program;

WHEREAS, Executive Order No. 31, Series Of 2022, provided for the reconstitution of the People's Law Enforcement Board of General Santos City ("PLEB");

WHEREAS, in light of the recent selection of the members of the PLEB, it is imperative to introduce amendments to the said Executive Order;

NOW, THEREFORE, I, LORELIE G. PACQUIAO, City Mayor of General Santos, by virtue of the power vested in me by law and the sovereign will of the people, do hereby order the following:

SECTION 1. Section 1 of Executive Order No. 31, Series of 2022, is hereby amended to read as follows:

"SECTION 1. COMPOSITION. Per Section 3, Rule 11 of the NAPOLCOM Memorandum Circular No. 2016-002, the PLEB shall be composed of the following:

The Chairperson of the PLEB shall be elected from among its members. The Secretariat of PLEB shall at least be a holder of a plantilla position and have completed a Bachelor's Degree, to be determined by the City Mayor.

Except as provided in this section or as may be provided by law, a public official or employee is **disqualified** for appointment or designation as member of the PLEB.

Applying the provisions of Article 152, Chapter IV, Title III, Book II of the Revised Penal Code, the members of the PLEB are considered persons in authority."

SECTION 2. REPEALING CLAUSE. All orders, memoranda, rules and regulations, or any part(s) thereof, inconsistent with the provisions of this Order are hereby revoked or modified accordingly.

SECTION 3. SEPARABILITY CLAUSE. If any provision or part hereof is held invalid or unconstitutional, the remainder of this Order not otherwise affected shall remain in full force and effect.

SECTION 4. EFFECTIVITY. This Order shall take effect immediately and shall remain in full force and effect unless otherwise revoked or amended.
