AN EXECUTIVE ORDER CREATING OVERSIGHT COMMITTEE ON THE REVISION OF FEES AND CHARGES OF THE LOCAL GOVERNMENT UNIT OF GENERAL SANTOS, DEFINING ITS COMPOSITION AND PROVIDING FOR ITS FUNCTIONS AND RESPONSIBILITIES

WHEREAS, the Department of the Interior and Local Government (DILG) and the Department of Finance (DOF) issued Joint Memorandum Circular (MC) No. 2019-01 dated May 17, 2019 on the Guidelines for the review, adjustment, setting and/or adoption of reasonable regulatory fees and charges of Local Government Units;

WHEREAS, the Joint MC was issued to ensure uniform procedures in the setting, review and/or adoption of reasonable fees and charges as provided under Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and to promote a balance between recovering the cost of services rendered by the LGUs and attracting investments in the LGUs in line with the Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018;

WHEREAS, the Joint MC No. 2019-01 shall apply to all fees and charges being imposed by the City of General Santos in rendering services to the public, whether regulatory or service fees, the purpose which is to recover the cost of service rendered, except when the rate or method for determining the rate has already been prescribed under the Local Government Code and other special laws;

WHEREAS, there is a need to create an Oversight Committee on the Revision of Fees and Charges to ensure the rates of fees and charges shall be revised at just and reasonable rates sufficient to recover the cost of services rendered taking into consideration the Local Fees and Charges (LFC) Toolkit in line with BLGF Memorandum Circular No. 020-2019 dated September 2, 2019.

NOW, THEREFORE, I, LORELIE GERONIMO-PACQUIAO, City Mayor of General Santos, by virtue of the powers vested in my by law and sovereign will of the people, do hereby order the following:

SECTION 1. CREATION AND COMPOSITION. The General Santos City Oversight Committee on the Revision of Fees and Charges is hereby created and shall be composed of the following:

SECTION 2. FUNCTIONS AND RESPONSIBILITIES. The Oversight Committee on Revision of Fees and Charges shall have the following functions and responsibilities:

1. Ensure that the guiding principles as prescribed under the Local Government Code and the Joint Memorandum Circular No. 2019-01 are observed in the proposed or revision of fees and charges.
2. Review the rationale for fees and user charges imposed by the LGU and methodology for determination of the fees schedule or rates.
3. Review and approve the data on the cost of delivering regulatory, service fees and charges, in order to compute the appropriate rates that will recover the cost, using the Local Fees and Charges (LFC) Toolkit.
4. Submit to the City Mayor and the Sangguniang Panlungsod the recommended proposed local revenue ordinance.

SECTION 3. REPEALING CLAUSE. All orders, memoranda, rules and regulations, or any part(s) thereof, inconsistent with the provisions of this Order are hereby revoked or modified accordingly.

SECTION 4. SEPARABILITY CLAUSE. If any provision or part hereof is held invalid or unconstitutional, the remainder of the Order not otherwise affected shall remain in full force and effect.

SECTION 5. EFFECTIVITY. This Order shall take effect immediately and shall remain in full force and effect unless otherwise revoked or amended.
