



EXECUTIVE ORDER NO. 82
Series of 2022

AN EXECUTIVE ORDER AUTHORIZING THE GRANT OF ADDITIONAL ALLOWANCE TO ALL QUALIFIED TEACHING AND NON-TEACHING PERSONNEL OF THE DEPARTMENT OF EDUCATION AND EARLY CHILDHOOD AND DEVELOPMENT, AND PHILIPPINE NATIONAL POLICE PERSONNEL OF THE CITY GOVERNMENT OF GENERAL SANTOS FOR FY 2022 IN THE AMOUNT OF FIVE THOUSAND PESOS (P 5,000.00).

WHEREAS, the Local Government Units, as prescribed in Republic Act (RA 7160) otherwise known as "The Local Government Code", are granted with fiscal autonomy wherein it may extend emoluments and benefits to qualified officials and employees in recognition of their dedicated and valuable service that leads to an effective and efficient delivery of services of the local government units;

WHEREAS, the City Government of General Santos recognizes the importance brought by the services rendered by the teaching and non-teaching personnel and PNP personnel in the effective and efficient delivery of the quality education to the students in the public schools and maintenance of the peace and order in the City;

WHEREAS, the City Government of General Santos has appropriated an amount of P33.9 million in the Appropriation Ordinance No. 11, Series of 2022 (Supplemental Budget No. 5 of the FY 2022), to cover the requirement to implement the grant of additional allowance;

WHEREAS, considering the availability of funds for the purpose and there being legal and factual basis, and in order to support the welfare and reward the services of all qualified teaching and non-teaching personnel of the Department of Education and Early Childhood and Development, and Philippine National Police personnel who courageously accepted the challenge of delivering quality education and maintaining the peace and order in these difficult times, the City Government of General Santos finds it prudent to grant the additional allowance;

WHEREAS, the City Government of General Santos has established guidelines for the granting of additional allowance to the teaching, non-teaching and PNP Personnel;

NOW THEREFORE, I, LORELIE GERONIMO PACQUIAO, City Mayor of General Santos, by virtue of power vested in me by law and the sovereign will of the people, do hereby order:

SECTION 1. RATIONALE. The establishment of this guideline is to primarily extend the recognition to the dedication and valuable service rendered by the teaching, non-teaching and PNP personnel that contributed to the attainment of the City Government of General Santos' quality education and peace and order through granting of additional allowance.

SECTION 2. FUNDING SOURCE. The additional allowance shall be chargeable against the Maintenance and Other Operating Expenses (MOOE) of the Office of the City Mayor an in accordance with the pertinent provisions of RA No. 7160.



SECTION 3. RECIPIENTS. The recipients of this additional allowance in the City government who must be at least in service as of the 30th day of November.

The amount to be granted shall be identified and recommended by the Local Finance Board to the Local Chief Executive subject to the availability of funds in a pro-rated manner which is as follows:

Length of Service	Percentage	Amount
4 mos. as of November 30, 2022	100%	5,000.00
3 mos. but less than 4 mos.	90%	4,500.00
2 mos. but less than 3 mos.	80%	4,000.00
1 mo. but less than 2 mos.	65%	3,250.00
Less than 1 month	50%	2,500.00

SECTION 4. IMPLEMENTATION PERIOD. The granting of this additional allowance shall be implemented immediately, and the monetary amount granted must be released not later than the 24th day of December.

SECTION 5. REPEALING CLAUSE. All orders, memoranda, rules and regulations or any part/s thereof, inconsistent with the provisions of this order are hereby revoked or modified accordingly.

SECTION 6. SEPARABILITY CLAUSE. If any provision thereof is held invalid or unconstitutional, the remainder of this Order not otherwise affected shall remain in full force and effect.

SECTION 7. EFFECTIVITY. This order shall take effect immediately.
