AN EXECUTIVE ORDER FURTHER AMENDING EXECUTIVE ORDER NO. 13, SERIES OF 2022, RECONSTITUTING THE GENERAL SANTOS CITY BIDS AND AWARDS COMMITTEE

WHEREAS, pursuant to Section 11, Rule 5 of the Revised IRR of RA 9184, each Procuring Entity is mandated to establish a Bids and Awards Committee to undertake the functions specified in Section 12 of this IRR in order to facilitate professionalization and harmonization of procedures and standards;

WHEREAS, as the Head of the Procuring Entity may deem it necessary to expedite the procurement process for practical intents and purposes, the HoPE may create separate BACs where the number and complexity of the items to be procured shall so warrant;

WHEREAS, the HoPE shall designate at least five (5) but not more than seven (7) members to the BAC of unquestionable integrity and procurement proficiency;

WHEREAS, Executive Order No. 10, Series of 2022, provided for the Reconstitution Of The General Santos City Bids and Awards Committee;

WHEREAS, Executive Order No. 13, Series of 2022, amended the abovementioned Executive Order;

WHEREAS, Executive Order No. 86, Series of 2022 amended the composition of the BAC;

WHEREAS, it is imperative to further amend said Executive Order in relation to the composition of the BAC;

NOW, THEREFORE, I, LORELIE GERONIMO PACQUIAO, City Mayor of General Santos City, by virtue of the powers vested in me by law and the sovereign will of the people, do hereby order:

SECTION 1. Section of Executive Order No. 13, Series of 2022 shall now read as follows:

"SECTION 1. COMPOSITION. — The Bids and Awards Committee (BAC) for the City of General Santos is hereby re-organized and reconstituted whose members shall be as follows:

- a. BAC for the Procurement for Goods and Consulting Services (*BAC-Goods and Consulting Services*)

Other provisions of Executive Order No. 13, Series of 2022 not inconsistent with this Order shall remain in force and effect.

SECTION 3. SEPARABILITY CLAUSE. — If any provision or part hereof is held invalid or unconstitutional, the remainder of this Order not otherwise affected shall remain in full force and effect.

SECTION 4. EFFECTIVITY. — This order shall take effect immediately.
