



**EXECUTIVE ORDER NO. 24**

**AN EXECUTIVE ORDER AMENDING EXECUTIVE ORDER NO. 66, SERIES OF 2022, "AN EXECUTIVE ORDER RECONSTITUTING THE COMPOSITION OF THE GENERAL SANTOS CITY PUBLIC MARKET COMMITTEE"**

**WHEREAS**, Section 147(c) of the General Santos City Revenue Code of 1996 provides the creation of the Market Committee to be composed of the City Administrator as Chairperson, a representative of the City Mayor, the City Treasurer or his or her representative, a representative of the Sangguniang Panlungsod, the City Legal Officer, and a representative of the Market vendors to be appointed by the City Mayor;

**WHEREAS**, the City Mayor Lorelie G. Pacquiao issued Executive Order No. 66, Series of 2022, reconstituting the GSC Public Market Committee to continue and to enhance the management and administration of market stalls, and to better address issues and concerns affecting the Public Market;

**WHEREAS**, there is a need to include the City Mayor's Office – Business Permits and Licensing Division expedite the processing of permits for businesses qualified to occupy the market stalls.

**NOW THEREFORE I, LORELIE G. PACQUAIO**, by the virtue of the power and authority vested in me as Mayor of General Santos City, do hereby order:

**SECTION 1.** Section 1 of Executive Order No. 66, Series of 2022 is hereby amended and shall now read as follows:

**"SECTION 1. COMPOSITION.** The General Santos City Public Market Committee shall be composed of the following:

**Atty. Francisco M. Gacal**, City Legal Officer  
**Atty. Dee Hajji U. Herrera**, Chief of Staff, City Mayor's Office  
**Ms. Geraldine A. Zamora**, Division Chief, City Mayor's Office – Business Permits and Licensing Division  
**Representative**, GSC Public Market Vendors Association

The Chairperson and members may authorize a representative in his or her absence or designate their permanent alternate to attend meetings of the Public Market Committee on their behalf.”

**SECTION 2. REPEALING CLAUSE.** All orders, memoranda, rules and regulations or any part/s thereof, inconsistent with the provisions of this order are hereby revoked or modified accordingly.

**SECTION 3. SEPARABILITY CLAUSE.** If any provision thereof is held invalid or unconstitutional, the remainder of this Order not otherwise affected shall remain in full force and effect.

**SECTION 4. EFFECTIVITY.** This order shall take effect immediately.
